

SUMMARY ANNUAL REPORT

FOR THE RAILROAD EMPLOYEES NATIONAL DENTAL PLAN

This is a summary of the annual report of The Railroad Employees National Dental Plan, EIN 52-1036399, Plan No. 505, for period January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$40,541,420 as of December 31, 2024, compared to \$30,982,082 as of January 1, 2024. During the plan year the plan experienced an increase in its net assets of \$9,559,338. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$94,688,351, including employer contributions of \$92,162,360, employee contributions of \$812,381, and earnings from investments of \$1,713,610.

Plan expenses were \$85,129,013. These expenses included \$4,649,190 in administrative expenses, and \$80,479,823 in benefits paid to participants and beneficiaries.

- transactions in excess of 5% of the plan assets;

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
